There was much discussion amongst the Commissioners regarding the construction progress of 3423 NW Byron Street, the Commissioners and everyone at the Special meeting walked across the street to 3423 NW Byron to look at the construction progress, then the meeting continued back at the Port office where it was agreed to by the Commissioners that will have a different contractor finish the Floor structure of the building and will fix the back patio door so it shuts and fits properly.
