## Kitsap Sailing Foundation (KSF) Report August 2024

- KSF will be hosting a Fall season Kickoff event on 8/20/24 at Silverdale Waterfront Park. We will be
  welcoming new HS and MS sailing families and using several of the fleet boats for short excursions to allow
  our new attendees to "get their feet wet" without actually getting their feet wet.
- 2. Summer "Learn to Sail" camps are wrapped up and continued to be successful with almost full capacities at each session. We thank the Port for their support in allowing us to use Port property to provide this opportunity for students and instructors to our community.
- 3. KSF Fall season is ready to begin with High School and Middle School Sailing teams returning for first practice Sept 3
- 4. As KSF has planned for last practice 10/31, we would like to request an extension to the dates for pulling some/all of the floating dock and or service pier until after this last practice date. Thank you
  - Josh Matthews inquired with the Ports marina contractor, Tim Knapp, about the possibility of leaving the floating docks and handling pier in place until after October 31, 2024. Tim confirmed that the floating docks would remain until after that date but noted that the handling pier's removal would depend on the tides to prevent any potential damage.
  - Commissioner Reese commented on the importance of removing support boats from the water and cleaning them to prevent the accumulation of barnacles on the hull.

## Clam Island Rowing (CIR) Report August 2024

#### **Programs:**

MASTERS ROWERS had a successful summer season with two Learn to Scull classes and 3 new scullers from those classes have joined our team. Members of CIR have participated in recent local regattas, three weeks ago in Poulsbo (Kitsap Invitational Summer Scrimmage) and then 8/11/24 on Bainbridge Island (Bill Richards regatta).

Juniors Report The juniors program will have a clinic August 19,20 and 21st in Silverdale. Then, junior rowers will be rowing as part of Sasquatch over at Keyport but will be using Sasquatch equipment.

#### Equipment/boat maintenance:

The heavy gas cans are a problem for our coaches who have to lift them in an out of our chase boats independently for our three day per week practices. The cans were filled fully during our last regatta with Kitsap Rowing Association and were too heavy to lift but now are empty enough that they can be placed in the sailing locker after practice. The rowing coach who manages the chase boat (independently) cannot safely tie the chase boat at an angle at the dock as the port has requested and we are unsure how to proceed.

#### Safety:

No safety issues since the last report.

Membership: There is ongoing discussion about Masters moving to Keyport to join Sasquatch in addition to the juniors moving to join Sasquatch but property insurance is an issue that needs to be secured for the Keyport Commissioners to take on our Masters Clam Island Rowing program. Ellen Strong mentioned that a Keyport port commissioner spoke with a representative of Enduris insurance company ( this is the company that provides property insurance for the rowing boats). The Keyport commissioner's understanding was that there may be a problem for the port of Keyport as they try to obtain property insurance for the boats. I will try to clarify what the issue is with Enduris. Clam Island Rowing has a liability insurance policy with US Rowing.

We are grateful to the Port of Silverdale for their ongoing support.

# **Port Properties**

# a. 9004 Washington

Commissioner Slate reported that the contractor is awaiting the performance bond, which is expected to be at the Port office by Friday, August 16th. He expressed a desire to negotiate a realistic completion date with the contractor.

A future tenant emailed regarding the need to repaint the entire building at 9004 Washington Ave. The Commission prioritized painting the south side of the building. Commissioner Slate will contact Greg from Finnery Construction to obtain an estimate for this work.

## b. 3215 NW Lowell Street

Tim Knapp from Tikar contacted KC Electric to request an estimate for replacing the electrical mast on the roof.

# c. Strategic Planning of Port Organization -

Commissioner Slate provided an update on the hiring process for the Office Administrator position. He reported that the second applicant interviewed was well-qualified. Commissioner Slate mentioned that further discussion will take place at the Special Meeting on August 28, 2024.

## Commissioner Reports

#### **Commissioner Reese**

Commissioner Reese reported attending the derelict vessel meeting with Kitsap County. He noted that on August 10th, a truck was parked in the overflow parking area, and another truck doing donuts collided with the parked truck.

### **Commissioner Scholfield**

Commissioner Schofield replaced the glass on the basement window at 9004 Washington. The webcam was functioning until last Monday, August 12th, when Wave cable went down. The cameras need to be reset.

#### **Commissioner Slate**

Commissioner Slate reported that he is working on obtaining estimates for speed bumps in the Port's boat launch parking lot and is meeting with contractors to brainstorm ideas. Tikar is assisting the Port in finding a roofing contractor.

He also discussed the guest speakers from the Kitsap All-Ports meeting, who are with the Department of Ecology, and spoke about Brownfields. A Brownfield is a property where the expansion, redevelopment, or reuse may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant. Commissioner Slate believes the Old Pub is a Brownfield and has received an estimate from Kat Trax for the demolition of the Old Pub building.

## **NEW BUSINESS**

Boy Scout Troop 1540 continued their annual tradition of cleaning up trash after Whaling Days 2024. Commissioner Reese made a motion to donate a \$1,000.00 to Boy Scout Troop 1540. (M/S/C –/Reese/Slate/ All)
