





RESOLUTION NO. 83-2

A RESOLUTION of the Commissioners of the Port of Silverdale to Adopt the Final Budget for the Tax Year 1984.

WHEREAS, the Commissioners of the Port of Silverdale have reviewed the Fiscal requirements, anticipated revenues and expenditures of the Port District, and

WHEREAS, a Preliminary Budget was prepared and approved as required by law, NOW THEREFORE,

BE IT RESOLVED BY THE COMMISSIONERS OF THE PORT OF SILVERDALE, KITSAP COUNTY, that the final Budget of the Port of Silverdale be adopted for the Tax Year 1984 in the amount of \$ 404,850, and that a property tax be levied to the Port District property owners in the amount of 106% of the 1983 taxes plus allowances for new construction to total approximately \$ 62,000, and to be assessed the property owners of the Port District for the Tax Year 1984.

RESOLUTION NO. 83-3

A RESOLUTION of the Commissioners of the Port of Silverdale to officially adopt the Port of Silverdale Comprehensive Plan and outline published September 1974, with amendments updating and detailing the Waterfront Park Plan of 1975 to the present time.

WHEREAS, the Commissioners of the Port of Silverdale passed by motion at their regular monthly meeting October 30, 1973 to accept the proposed draft of the Comprehensive Plan and outline as prepared and modified, and,

WHEREAS, the Master Plan for a Waterfront Park and Harbor Improvement was accepted and adopted following a public hearing on April 12, 1976 as advertised, and a joint Agreement between the Kitsap County Commissioners and the Port of Silverdale Commissioners to proceed with development of said Park in accordance with Resolution No. 76-2 of April 15, 1976, and to request IAC funding as prescribed, and,

WHEREAS, the Commissioners of the Port of Silverdale adopted the Kitsap County Comprehensive Park and Recreation System Plan dated October 13, 1980, related to the Silverdale Waterfront Park area by Resolution No. 82-1 of August 19, 1982, and,

WHEREAS, Consultants were engaged to modify the Silverdale Waterfront Park Plan to provide for harbor dredging and a floating breakwater to provide better usage of the harbor area. The resulting proposed Waterfront Improvement Project Master Plan dated August 1983 was accepted at a regular meeting of the Commissioners of the Port of Silverdale and adopted by Resolution No. 83-1 of August 18, 1983, and,

WHEREAS, the adopted Waterfront Improvement Project Plan was presented and accepted at various Community organizations at their regular meetings, namely, CK Chamber of Commerce, Silverdale Rotary, Silverdale Lions Club, and the Silverdale Advisory Committee, to create more Community support and input, NOW THEREFORE,

BE IT RESOLVED BY THE COMMISSIONERS OF THE PORT OF SILVERDALE, KITSAP COUNTY, to officially adopt the Port of Silverdale Comprehensive Plan and outline published September 1974 with modifications and revisions to update and include the Waterfront Park and harbor Improvement Plan to the present date of October 1983.

ADOPTED at the regular monthly meeting of the Commissioners of the Port of Silverdale, Kitsap County, Washington on the 18th day of October 1983 with votes on this resolution registered (2) for, (0) against, (1) absent.
